RE-REGISTRATION IS OPEN!

UK NEQAS Haematology re-registration opens on February 11th 2019 and will close on March 8th. Re-registration enables you to confirm your EQA requirements for the next participation year, update your contact details and provide us with a purchase order against which we can raise an invoice for the services provided. Our re-registration procedures are now entirely online and all communications are sent by email. Even if you have no changes to make, please take a few moments to review the tests for which you are registered and your registered contact details. It is essential that we have an up-to-date email address for each contact, especially the 'Main' contact so that we can keep you informed of services throughout the year. It is also important that we have the correct details for the 'Consultant' contact, as this is the person who will be contacted in the event of concerns about performance. The 'Consultant' contact may be the medical consultant responsible for the service, the Head of Department or person responsible for guality within the department. We will use your email address to inform you when distributions open, when reports are available and any changes to service. We will also contact you by email to discuss any problems with account management. With your permission, we will use your email address to notify you of questionnaires and services in Haematology and laboratory medicine that may be of interest to you. We do not share your email address with any non-UK NEQAS organization.

EQATE LAUNCHED

The new UK NEQAS Haematology EQATE digital platform was launched in October 2018 with the transfer of the Digital Morphology for CPD from the Digital Slidebox[™] system. All participants have been successfully transferred to the new platform and we are grateful to everyone for their support and patience during the change. We will provide an extra case in this year's schedule as part of the beta testing of the new system. EQATE is planned to be more flexible and wide-ranging than Digital Slidebox[™] and we will be adding extra modules to provide electronic EQA cases, interpretive cases, competency assessment and educational resources in the future. There will also be developments in the Digital Slidebox[™] platform.

PILOT PROGRAMMES

UK NEQAS Haematology has launched 2 pilot programmes, which you can register for as part of your re-registration. The pilot programmes are not included in the scope of our accreditation to ISO17043 but will be submitted for accreditation once they are sufficiently well developed.

The **Glandular Fever Screening Test pilot EQA** has planned distributions in July 2019 and January 2020, each containing two specimens. Because of the anticipated interest in this programme, there will be a fee of £125 per laboratory for this year, to cover the cost of materials, postage and packing. The frequency of distribution will be assessed with participants during the year, once full online data entry and reporting has been developed. Initially, participants will be asked to return results online but separately from the main web-entry pages, as we work with our software provider to integrate the programme with our other services.

The **Pyruvate Kinase quantitative assay pilot EQA** has been added to our red cell enzymopathies suite, alongside the long-established G6PD programme. This is an international development that has the scientific support of the EuroBloodNet project. We plan for two distributions during the year, which will be planned around the availability of survey material. There is no charge for the PK pilot programme in this year.

Steering Committee and SAG Membership

We welcomed Dr Peter Carey and Ms Nicki Lawrence to the Morphology SAG and Ms Edna Young as Lay Member to the Steering Committee.

We bade farewell, with thanks, to: Dr Barbara Wild and Ms Mary Ann Cameron

Dr Steve Keeney became Special SAG chair and Mr Alun Roderick General SAG chair. We owe special thanks to Mr Ian Mellors, who stood down as GSAG chair.

DNA DIAGNOSTICS SCORING CHANGES

The scoring for the DNA Diagnostics for the Haemoglobinopathies programme includes performance assessment for globin gene mutational analysis, interpretation, recommendations for follow up and use of the HGVS nomenclature. The performance assessment has been reviewed with our expert panel following feedback from participants and scoring for compliance with the recommendations and HGVS nomenclature in the model answer will in future be provided for information and advice only. Only the scoring for mutational analysis and interpretation will be included in cumulative scoring. Because there is a waiting list for this programme, any laboratory that fails to return for a full year will be asked to step down.

MANUAL RETIC COUNTING

Very few laboratories are now registered for manual reticulocyte counting. Although this module in the Retic counting programme remains just viable, we will review the future of this option again with our General Automated Counting Scientific Advisory Group in March. If you are still registered for manual, microscopic retic count, could you contact the Director (<u>Barbara.delasalle@nhs.net</u>) with your reasons and an indication of the impact the withdrawal of this option would have?

ISO 17043 ACCREDITATION UPDATE

UK NEQAS Haematology and Transfusion had the last surveillance visit of our current cycle in August 2018 with just a couple of minor issues found. Our 2019 visit will be a full assessment. For the full scope of our accreditation : www.ukas.org.uk; Centre number 7805.

HAEMOGLOBIN A2 AND S SCORING

Scoring for Hb A₂ and Hb S quantitation has for some time been assessed against the method trimmed means for HPLC or capillary electrophoresis, mainly for historical reasons arising from the earlier era of manual methods. This scoring approach has caused some anomalies in performance assessment between HPLC and capillary electrophoresis users, which we have dealt with by adopting the all methods trimmed mean as the target from August 2018. Evaluation of the change has shown no adverse impact on any group of participants and it will now be made a permanent feature. We will still provide both a method trimmed mean and a sub-method trimmed mean value (i.e. a value for an individual analyser model) for information. Sub-method trimmed mean values are only supplied where there is a minimum of twenty instruments registered for an individual analyser.

FAREWELL TO SBB CYTOCHEMISTRY EQA

Following consultation with our Morphology Scientific Advisory Group, the Sudan Black B / Myeloperoxidase module of the Cytochemistry programme will be withdrawn from April 2019. The number of participants registered for SBB staining has fallen over recent years as laboratories have changed to other, more effective, diagnostic methods. If any laboratory requires some alternative means of demonstrating interlaboratory comparability for this test, they should contact the Scheme Director and we will attempt to put you in touch with other participants who might be interested in arranging a specimen exchange programme. This change does not affect the Haemosiderin module (Iron Staining) and will allow use to devote time to improving the design of the Haemosiderin module and the cases distributed.

THANKS TO OUR MORPHOLOGY CHAMPIONS

UK NEQAS Haematology is enormously grateful to our 'Morphology Champions', listed on the right, who have supplied us with a variety of samples which we have been able to use to add to our stock of blood films for our survey library. UK NEQAS Haematology distributes sixteen cases every year for the Blood Films for Morphology programme and these are prepared from clinical samples surplus to diagnostic testing, provided by participant laboratories. When our expert morphology panel met this year they highly commended the range and quality of cases that had been donated. We still need cases and have a 'wishlist' for samples we would like to receive.
