PRICE CHANGES

Programme prices for 2026/27 have increased by approximately 5% for most schemes, reflecting inflationary costs.

REMEMBER TO CHECK YOUR CONTACT DETAILS

Your online account lets you manage contacts easily. You can add, update, or deactivate contacts as needed.

Please make sure you have:

One main contact (used for sample delivery — the address must match your delivery address)

One invoice contact

A consultant contact (required for UK clinical laboratories)

You can also add:

Trial contacts (notified when samples are despatched)

Report contacts (notified when reports are issued)

Don't forget to deactivate contacts who have left your organisation, as they may still have access to data and reports!

Changes to the main contact/delivery address will apply from the first distribution of the 2026/27 schedule.

All other contact updates take effect immediately.

Please note that deregistration from full (scored) programmes requires contacting us first.

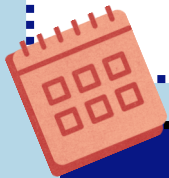

2027/28 re-registration period.

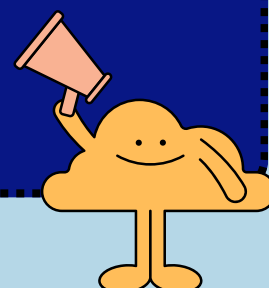
A pre-pilot for a *RHD*-genotyping scheme

NQAAP: UKNEQAS POSITION STATEMENT

UK NEQAS regrets the pause in activity of the QAPC and NQAAP oversight of laboratory performance from January 1st, 2026, as notified by the RCPATH, IBMS and LabMed. UK NEQAS supports the need for an independent system of review of both laboratory and method-related performance within the UK.

UK NEQAS centres will continue to manage performance concerns internally after January 1st 2026. In the case of persistent unsatisfactory or poor performance of either testing sites or methods, UK NEQAS Organisers will continue to work with the support of the Schemes' Steering Committees, other EQA providers, commercial companies and/or the MHRA, as required, to resolve the concern in the interest of patient safety. PACKAGING UPDATE

This is a safety precaution just in case the documentation and the clamshell become separated whilst in transit!

UNIFIED LOGINS

From April 2026, our website will utilise unified logins, which means you only need to log in to our main website once to allow you to access reports and data entry for all of our programmes, including PTT and FMH.

You will be able to login with either an email address and password, or by using a PRN, WebID and password. Please note that the same password will not automatically work for both.

The 'blue screen' login used for accessing PTT and FMH will still continue to work, but using the single login on our website will make the process smoother and is the way we plan for our new website to work.
